

Nomination Guide

Complete this fillable PDF on a computer, save a copy, and print it; or print the blank packet and complete it by hand. Attach additional pages when needed. Review long field entries before printing: text beyond the visible field may not print.

Eligibility and consideration

- At least 25 years of active participation in the RV or manufactured housing industry.
- Significant, lasting contributions beyond normal professional expectations; a respected, ethical, and honorable reputation.
- Contributions may include leadership, innovation, volunteerism, governance, advocacy, or other industry-shaping efforts.
- If selected, the nominee must attend the induction ceremony unless deceased.
- Complete packets remain active for five consecutive induction cycles, beginning with the year following submission. Submission does not guarantee induction.

Deadline and supporting materials

All materials must be received by November 30. Include the completed nomination form, nomination letter, professional biography, headshot, three professional recommendation letters (one page each), and nominee and nominator contact information. All sections must be complete. Late submissions are not accepted.

Submission and review

Mail the completed packet and supporting materials to: RV/MH Heritage Foundation, Attention: Hall of Fame Selection Committee, 5600 Executive Parkway, Elkhart, IN 46514. For the online submission option, visit the Nomination Process page on the Foundation website.

Staff review submissions for completeness and eligibility. Receipt confirmation follows that review. Selection Committee deliberations and selections remain confidential; selected inductees remain confidential until the official Foundation announcement.
